I am requesting funding for Red Bay Water and Gas Well and Treatment Plant Construction in Fiscal Year 2027. The entity to receive funding for this project is Red Bay Water and Gas, located at 302 4th Avenue SE Red Bay, AL 35582. The funding would be used for the drilling of well(s) supply to secure a range flow from 600 GPM to 1,200 GPM. Construction of Treatment Facility will provide Iron/Manganese removal, PH adjustment, corrosion prevention and disinfection. Additional work involves upgrading the Distribution Piping and providing additional storage. The project is an appropriate use of taxpayer funds because will ensure an additional water source is available for the citizens of Red Bay.
